## 5. Kiteboarding

- (a) The Windsurfing and Kiteboarding Committee did not receive a verbal report from the Chairman of the Windsurfing and Kiteboarding Committee about the Kiteboarding Competition Rules and their future development of the ISAF Course Racing World Championship. This was discussed under Agenda item 7(b).

4) RRS 14: Delete the changes proposed to RRS14. Rule 14 become rule 14.1. Add new text for RRS 14.2: 'In elimination series, if the contact is minor and doesn't cause damage or injury or capsize, no board shall be penalised.' The Addendum Q WP should look at the proposed text for this area.

5) In the preamble of Section D – delete the proposed changes.

6) RRS63.3 (b) is not deleted. Add as a last sentence in this rule 'In elimination series, the protest committee may take evidence in anyway it considers appropriate and may communicate its decision verbally .

7) Delete RRS 66 and replace with 'In an elimination series reopening a hearing is not permitted'.

8) B10: The addendum should be B1. A WP should prepare Addendum B1 before the Mid-Year meeting in May 2012. Members of the WP are: Bruno De Wannenmaeker, Ilker Bayindir, Andros Poksi, Dusan Vanicky, Rich Jeffries and Kamen Fillyov.

### 9. 2014 Youth Olympic Games – Windsurfing Events

The Windsurfing and Kiteboarding Committee received a progress report from the ISAF Events Manager. It was noted that the IOC had confirmed 4 medals for sailing; boy's one person dinghy, girl's one person dinghy, boy's board and girl's board. There would be 100 athletes at the event and the age category would be 15/16. The Windsurfing Committee recommended that the equipment chosen for the board events should be the Techno 293. A representative from the ISAF Youth Olympic Games Working Party also gave a progress report and discussed some of the format proposals that were being discussed.

### 10. 2012 Olympic Sailing Competition

- (a) The Windsurfing and Kiteboarding Committee received a report from the ISAF Events Manager. It was noted that all tickets for the sailing events had sold out and there will be 4,600 spectators per day at the Nothe venue. The ISAF Events Manager reported that the Weymouth & Portland International Regatta 2011 was a great success. Some new concepts were trialled; course rotation and rotation of fleets through the Nothe medal race course. It was reported that the race management was of a very high quality. It was noted that the media coverage was disappointing and that more should be done by ISAF to ensure full coverage of Test Events. With regards to the 2016 Olympic Sailing Competition it was noted that the Rio organisers had been in contact with ISAF over the schedule and format of the 2016 Olympic Sailing Competition. The ISAF Events Manager confirmed that the Rio bid book stated that there would be grandstand seating for 10,000 spectators adjacent to the medal race course.

### **11. ISAF Sailing World Cup**

The Windsurfing and Kiteboarding Committee received a progress report from the ISAF Events Manager. Work is continuing on the standard documentation: Notice of Race, Sailing Instructions, policy documents, etc. It was also noted that there was good co-operation from the event organisers and the ISAF officials appointed to the events.

### **12. 2011 ISAF Sailing World Championships**

The Windsurfing and Kiteboarding Committee received a progress report from the ISAF Events Manager. It was noted that successful Test Event had taken place in November 2010 and that both ISAF and Perth 2011 had learnt a great deal. The ISAF Events Manager reported that all the plans were in place for the Championships and that the documents and policies in place for the event would be published shortly. It was noted the reduced size of the course close to the beach.

### **13. Class Reports**

The Windsurfing and Kiteboarding Committee received written progress reports from representatives from the International and Recognized Windsurfing and Kiteboarding Classes.

### **14. Equipment**

- (a) The Windsurfing and Kiteboarding Committee received a progress report from the representative of the Windsurfing and Kiteboarding Committee on the Equipment Committee, about the meeting which was held at the ISAF Secretariat in Southampton earlier in the year.

- (a) The Windsurfing and Kiteboarding Committee received a brief update from IWA.

### **16. Windsurfing Learn to Sail Training Programme**

The Windsurfing and Kiteboarding Committee received a written report from the ISAF Training & Development Manager regarding the addition of Windsurfing to ISAF LSTP.

The Windsurfing & Kiteboarding Committee noted the Chairman's report to the ISAF Council meeting of 10 November 2011 on the activities of the Windsurfing and Kiteboarding Committee for the period 1 January 2011 to date.

(b) Medal Race

The Windsurfing and Kiteboarding Committee recommends that in order to reduce the number of judges and boats required for windsurfing events there should only be 1 Judge per boat for medal races and fleet races.

The Windsurfing and Kiteboarding Committee would like it noted that submission 006-11 from the International Kiteboarding Association about Athlete's Commission – Constituting the Commission – Terms of Reference should have been included on the Windsurfing & Kiteboarding Committee agenda. Thomas Holc from the Executive Committee said that he felt the Executive Committee would reject this submission. The Windsurfing and Kiteboarding Committee would like it noted they support the ISAF Classes Committee recommendation to approve this submission.

(d) Ceri Williams would like further information on how alternates can vote on all Committee meetings including Council. He said that as far as he was aware alternates have the same responsibilities as the member they replace (including voting). The ISAF Events Manager would look into this further and get back to the Committee.

(e) The Windsurfing and Kiteboarding Committee would like it noted that submission 036-11 from the Chairman of the Development and Youth Committee about Guidance on Youth Age Ranges – Definition would like it noted they do not support any regulation telling classes what age groups they should have (and at what age to define youth and junior). It was also noted they support the ISAF Classes Committee on their decision as well

There being no further business, the meeting was closed.
