Type 'C'

In the Rules

- Minimum weight 16 kg
- Sail size: 8.5 for light sailors (< 82kg)
- Sail size: 9.5 for heavy sailors (> 78kg)

For Voting

• Maximum fin length 40cm (vote) YES – APPROVED

Class Constitution

Minor amendment/changes to the Class Constitution For Voting

- Replace ISAF by World Sailing YES APPROVED
- Typo error Correction Art 10.2 (last line):
 - Any Member or NCA or Fleet may submit agenda items to the secretary no later than thirty -(40)- (30) days prior to the date of the AGM.. YES APPROVED

Requalification by Word Sailing

• What being a World Sailing Class means?

- World Government body recognition
- Ability to hold World Championships
- Acknowledgment as Class having international standards and fair competition
- Eligibility for World Sailing Events, including Olympic Sailing competition
- Get WS support for technical services such as class rule administration, builder licensing, production windsurfing board registration
- Appointment of one Class representative at WS (= 1 vote in World Government Body)
- Through WS plaque, WS can collect fees to be paid back to Class
- WS Class can carry official advertising

• What is required (how to get there)?

- Precise application process :
 - Deadline 31st July for consideration at WS Annual Meeting in November
- Comply with qualification process set out in WS regulation 10, including:
 - Class worldwide activities distribution
 - Requiring written confirmation from local MNAs
 - Active Class/ Owner Association
 - Copy of Constitution
 - Class rules in WS format
 - Adopting Equipment Rules of Sailing
 - Payment of WS application fees by July 31st.

Events/Races - Discussion

- 1. Future Events/Races
- 2. Question about next European venue that is not defined yet.
 - Ceri Williams has explained process of selection, contractual aspects between IWA and Club organizer and the need to have a minimum number of sailors so that the cost is reasonable
- 3. Comments about ID2CA intention to hold championships separately from RB when possible
 - In cases RB/D2 sailors have to choose between classes in a joint event, since both classes are sharing same base of sailors then they are annihilating each other. Therefore, ID2CA is exploring events with other sailing classes, in order to avoid such a conflict. No alternative has been found yet and issue is still under assessment.
- 4. Comments from sailor questioning requirement to go through IWA for holding championships in France.
 - Followed by a general discussion about IWA Sanctioned Event (or ISE) vs. regional local races
 - Emphasized that social, friendly races are encouraged at local, regional and national levels, which will prepare sailors to championships organized by ID2CA/IWA

Q&A

1. D2 racing course (triangle within Trapezoid)

- Question/Comment Sailor was saying it was not easy to handle during race (crossing RB pathways)
- Response We are conscious that having 2 different track courses merged within same racing area wasn't ideal; it was club organizer decision to merge classes in a unique racing circle. However, ID2CA will propose alternatives courses for future events when sharing racing track with other classes to be discussed within the Technical Committee
- 2. Sharing information on local events
 - Question/Comment Request that ID2CA should publish information regarding local events for D2
 - ID2CA will determine the optimal way to share information regarding local and will advise members – possible solutions are;
 - The ID2CA racing calendar
 - Dedicated pages (Facebook...) for regions to be maintained by local members
